## Coronavirus Safety Information

- **Symptoms: Fever and a dry cough. Shortness of breath as a severe symptom.**
- Wash your hands frequently. Soap or 60%+ alcohol-based hand sanitizer is sufficient.
- Try to stay at least six feet away from other people. The reason is that coughs and sneezes can travel roughly six feet, which is the primary vehicle for infection.
- While in public, avoid touching surfaces, and wash your hands afterwards. The virus can remain active on some surfaces for up to 3 days.
- Avoid touching eyes, nose and mouth. The soft tissue here is particularly vulnerable to infection.
- Cover your cough with your elbow or with a tissue. Dispose of tissues immediately.
- Older people are particularly vulnerable. If you are showing symptoms, especially difficulty breathing, seek medical assistance.

The COVID-19 coronavirus has an up-to-fourteen day incubation period, meaning you may be sick for up to two weeks before showing symptoms. This makes it possible to be infectious without appearing sick, and is why you should self-isolate as much as is reasonably possible.

## ARTIST EMERGENCY RESOURCES

- [CERF+](#) is the Craft Emergency Relief Fund, a nonprofit that assists artists with natural disasters that effect their livelihood. Currently, because of the anticipated volume of requests, CERF+ is only assisting artists who have been infected with the virus and require intensive medical care.
- The [Society of North American Goldsmiths](#) has compiled a page listing artist relief resources.
- [COVID-19 Freelance Artist Resources](#) is a website listing various resources for independent artists who are in need. The website has been set up as a community effort by several artists.
- The [Seattle Metals Guild](#) is offering members up to \$500 for an emergency relief grant, taken out of their Emerging Artist Grant which totals \$2,500. These emergency grants will be awarded according to need. You can apply for the grant [here](#). They are also [accepting donations](#).
